

- Safety and functional tests according to ATEX.

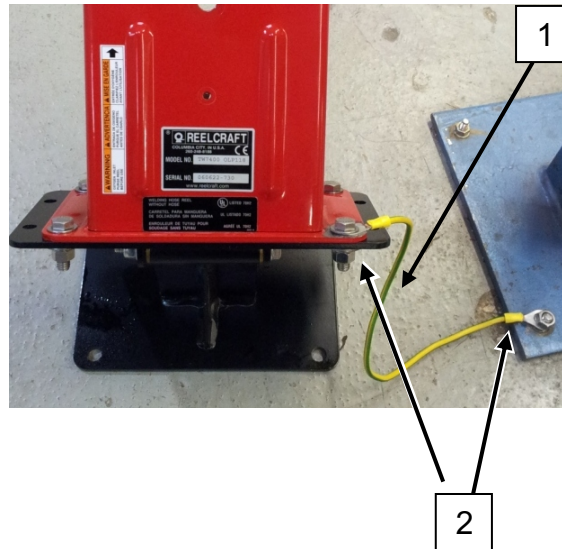
Safety instructions explosion protection

- Always behave in such a way that fire and explosion hazards are avoided.
- All parts of the grounding concept must be properly connected to the higher-level machine.
- Bringing ignition sources into the potentially explosive area is prohibited.
- The temperature of the pumped medium must not exceed 99 °C.
- Assembly / repair work may only be carried out if there is no explosive atmosphere.
- Handle the hose so that no sparks can occur.
- Regularly remove accumulations of dust. Do not stir up dust.
Maximum dust thickness < 5 mm.
- Risk of fire and explosion from the use of flammable cleaning agents.
Only use non-flammable cleaning agents that are suitable for the intended purpose.
- Only conductive hoses may be used.
- In the event of mechanical damage, the reel must be taken out of service immediately, since frictional heat and sparks can occur.

grounding concept

- (1) Grounding cable
 - (2) Fixing screw
1. Connect the supplied ground wire to the mounting screw on the reel frame.
 2. The intended, unvarnished area is to be used for this.
 3. Connect the other end of the cable to earth potential.
 4. Check the connection for conductivity using an ohmmeter.
 5. Check this connection for rust before each use of the reel and always ensure discharge.
